Slippery Rock Borough convened this date at the Slippery Rock Borough Building located at 306 East Water Street, Slippery Rock Borough, Butler County, Pennsylvania. The meeting was called to order at 7:00 p.m. followed by the Pledge of Allegiance.

A motion was made by Tom McPherson to approve Officer Graham attending a TASER CEW Instructor Course on July 18<sup>th</sup> and 19<sup>th</sup> at the Cecil Township Police Department at a total cost of \$ 495.00 plus mileage for a 2-day course to become a certified instructor. Seconded by Denton Zeronas, motion carried with Ron Steele casting a nay vote.
