President Russ Karl called the meeting to order at 7:00pm.

Mayor Jondavid Longo led the Council members in the Pledge of Allegiance.

## **Outside Entity Reports:**

- -Slippery Rock University: Robb King stated that students are currently on Winter Break. Spring Semester begins January 19, 2021. During the first week, students will be attending online while COVID testing is being done. The students will then continue to attend class 80% on-line and 20% in person. Robb also reported that Rita Abent, the University's Chief Communication and Public Affairs Officer has passed away.
- -Slippery Rock Community Library: None
- -Slippery Rock Municipal Authority: Shaun Brown reported that the Main Water Line Project is completed. He stated that any concrete repair or paving that needs to be done will be completed in the spring.
- -Slippery Rock Parks and Recreation: Mary Messer wished everyone a Happy New Year and reported that the Park is continuing to offer programs including a new Trampoline Fitness Class. The Spring Brochure has been released including all programs and activities that have been modified to adhere to COVID-19 guidelines. Mary stated that basketball starts in 2 weeks and that the first Peak n Peek scheduled trip was well attended with 54 students. Lastly, Mary stated that two new Seesaws that were purchased with funds donated by Gladys Travis have been installed.
- -Slippery Rock Volunteer Fire Company and Rescue Team: Chief Ryan Hanchosky and Assistant Chief Kurt Reasner were present to report that ambulance subscriptions are available for \$40. Fish dinners will start February 19, 2021 and will run for 7 weeks. Gene Allison asked how long the subscriptions will be sold for \$40. Ryan stated that he would inquire about it.
- \*Shawn Pugh spoke on behalf of Slippery Rock Borough and thanked the Slippery Rock Volunteer Fire Company and Rescue Team and the Slippery Rock Municipal Authority for their help with the putting up and taking down of the 35 foot Christmas Tree this year.

### **Mayor's Comments:**

The Mayor congratulated the Chief and Assistant Chief on their appointments and apologized for not being able to have an Installation dinner. He commented that the fundraiser that helped restaurant workers is in process and that each worker received a \$50 cash relief payment.
