## Citizen Input:

Ian Oman from 120 Parklane Drive addressed Council regarding the site selection for the flag in the park. Mr. Oman stated that property owners near the park should have been consulted and considered when deciding the site for the flag. He is concerned for his property value, and noise disturbances that a large flag could produce. Ron Steele stated that the flag, along with the site has been discussed for over a year by Council and the Park Board. Christian Laskey reported that all regulations including height restrictions and safety concerns were vetted before the flag was erected. The mayor added that a soil test had also been conducted. Mr. Oman ended the conversation with his hopes that in the future, Council consider residents input on matters that would directly affect them.
