1. § 213-8 Prohibited Acts.

- a. No solicitor or peddler shall:
- b. Sell any product or type of product not mentioned in his license.
- c. Hawk or cry his wares upon any of the streets, alleys, sidewalks or public grounds in the Borough.
- d. When operating from a vehicle, stop or park such vehicle upon any of the streets or alleys in the Borough for longer than necessary in order to sell therefrom to persons residing or working in the immediate vicinity, except as part of an organized fair or festival.
- e. Engage in any business activity, except by prior appointment, at any time before 10:00 a.m. or after 8:00 p.m. on any day of the week unless as part of any organized fair or festival.
- f. Carry on transient retail business activities at a private residence or business premises exhibiting a sign reading "no solicitors" or words of similar meaning.
- g. Carry on transient retail business activities at a private residence or business premises on the list of residences requesting no solicitation ("no soliciting list") as supplied by the Borough to any license holder.
- h. Refuse to leave the premises when asked to do so by the occupant of the premises.
- i. Conduct activities in an unlawful, fraudulent, or criminal manner or so as to constitute a breach of the peace
