Citizen Input for Agenda Items Only:

Regina Greenwald thanked Denton Zeronas and Royce Lorentz for their Service as it will be the last meeting for both as councilmen. Regina expressed her disagreement with the amendment to the Mayor's salary and then asked the solicitor if it is legal for Serafine Hauling to sell the garbage contract to Aiken. Solicitor Black stated that it is legal if they gain consent from the Borough. Regina asked that council consider the look and height of a proposed building when considering a buyer for the vacant lot. Lastly, she reported that she is happy with the Borough's decision to hire a laborer for the street department.

Mike Pavelek addressed council regarding the amendment to the mayor's stipend. He stated his opinion that council's stipend should be increased as it might incentivize young adults to run for office. Lastly, he asked about the garbage contract. He questioned if the contract as defined would remain the same. He suggested that new residents should be informed of what can and cannot be picked up.

*John Hicks made the motion to appoint Daniel Straite to the Slippery Rock Area Park Board for the remainder of the term ending in 2025.

*Ron Steele made the motion to appoint Samantha Kelly to the Slippery Rock Municipal Authority for a four -year term. Royce Lorentz provided the second. The motion passed unanimously following a roll call vote.

*John Hicks made the motion to approve the 2024 Slippery Rock Area Parks and Recreation Budget. Royce Lorentz provided the second. The motion passed with Denton Zeronas being the only abstaining vote.

*John Hicks made the motion to advertise the amendment to Chapter 71, Compensation established for the Mayor. Royce Lorentz provided the second. The motion passed four to two with John Hicks, Royce Lorentz, Denton Zeronas and Jeff Campbell being for and Lauren Christmann and Ron Steele being against.

*Denton Zeronas made the motion to advertise the hiring of a full -time laborer at the rate established in the Municipal Employees of Slippery Rock Collective Bargaining Unit. Royce Lorentz provided the second. The motion passed unanimously following a roll call vote. *John Hicks made the motion to approve the 2024 meeting dates for Council, Planning Commission, and the Zoning Hearing Board. Denton Zeronas provided the second. The motion passed unanimously following a roll call vote.

*Ron Steele made the motion to approve Slippery Rock Borough's 2024 general operating budget. John Hicks provided the second. The motion passed unanimously following a roll call vote.
