Laborer Position: The Hiring Committee has narrowed the applicant list for the laborer position to 10 candidates. All candidates have been contacted. Seven of those have scheduled interviews that will take place on February 7, 2024.

Downtown Redevelopment Meeting: The Comprehensive Plan meeting with Downtown Redevelopment will take place on Wednesday February 28, 2024 at 6:00 pm at the Slippery Rock Fire Hall. All are invited to attend.

PennDOT Speed Study: Pennsylvania State Representative, Tim Bonner has requested that Penn Dot perform a speed study in the Borough. New Castle Street and Franklin Street will be the targeted areas.

Elm Street Stormwater: The Slippery Rock Street Department discovered a sink hole which led to the discovery of a failing underground vault on Elm Street. The engineers looked at it last week and fixed it temporarily while determining a permanent solution.
